#### **Definitions and Abbreviations**

Definitions and Abbreviations The following tables contain scientific terms and measures, some of which may require explanation.

Action Level: The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.

Action Level Goal (ALG): The level of a contaminant in drinking water below which there is no known or expected risk to health. ALGs allow for a margin of safety.

Avg: Regulatory compliance with some MCLs are based on running annual average of monthly samples.

Level 1 Assessment: A Level 1 assessment is a study of the water system to identify potential problems and determine (if possible) why total coliform bacteria have been found in our

water system.

Level 2 Assessment: A Level 2 assessment is a very detailed study of the water system to identify potential problems and determine (if possible) why an E. coli MCL violation has occurred

and/or why total coliform bacteria have been found in our water system on multiple occasions.

Maximum Contaminant Level or MCL:

The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

Maximum Contaminant Level Goal or MCLG: The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

Maximum residual disinfectant level or MRDL: The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial

contaminants.

Maximum residual disinfectant level goal or MRDLG: The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to

control microbial contaminants.

MFL: million fibers per liter (a measure of asbestos)

mrem: millirems per year (a measure of radiation absorbed by the body)

na: not applicable.

NTU: nephelometric turbidity units (a measure of turbidity)

pCi/L: picocuries per liter (a measure of radioactivity)

Treatment Technique or TT: A required process intended to reduce the level of a contaminant in drinking water.

## **Information about your Drinking Water**

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. Contaminants that may be present in source water include:

- Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.
- Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban storm water runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.
- Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban storm water runoff, and residential uses.
- Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban storm water runoff, and septic systems.
- Radioactive contaminants, which can be naturally-occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, EPA prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

You may be more vulnerable than the general population to certain microbial contaminants, such as Cryptosporidium, in drinking water. Infants, some elderly, or immunocompromised persons such as those undergoing chemotherapy for cancer; persons who have undergone organ transplants; those who are undergoing treatment with steroids; and people with HIV/AIDS or other immune system disorders, can be particularly at risk from infections. If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. #### Information about Source Water

CONSOLIDATED WSC LATEXO CITY PLANT Y A purchases water from HOUSTON COUNTY WCID 1. HOUSTON COUNTY WCID 1 provides purchased surface water from Houston County Lake located in Houston County. This is a spring fed lake, which also collects run-off through the Little Elkhart Creek water shed. The activities conducted in this water shed are primarily farming, ranching and timber growing and harvesting. The most likely source of contamination would be caused from these activities, and would include fertilizer, fertilizer by-products (nitrates and nitrites), herbicides and pesticides.

A Source Water Assessment for your drinking water source(s) has been conducted by the TCEQ for your water system. The report describes the susceptibility and the types of constituents that may come into contact with your drinking water source based on human activities and natural conditions. The information in this assessment allows us to focus our source water protection strategies.

<sup>\*</sup>In Q3 and Q4 of 2018, we failed to provide the minimum chlorine concentration required by TCEQ in some parts of the distribution system. We used public notices to communicate this deficiency and performed a free chlorine conversion and unidirectional flushing to return to compliance. We are now investigating long-term source water and treatment changes which will provide us with more consistent disinfectant concentrations in the future.

# Mandatory Language for a Maximum Contaminant Level (MCL) Violation MCL, LRAA / HAA5

The Texas Commission on Environmental Quality (TCEQ) has notified the Consolidated WSC Latexo City Plant Y A TX1130012 that the drinking water being supplied to customers had exceeded the Maximum Contaminant Level (MCL) for haloacetic acids (group of five). The U.S. Environmental Protection Agency (U.S. EPA) has established the MCL for haloacetic acids (group of five) to be 0.060 milligrams per liter (mg/L) based on locational running annual average (LRAA) and has determined that it is a health concern at levels above the MCL. Analysis of drinking water in your community for haloacetic acids (group of five) indicates a compliance value in quarter two 2019 of 0.061 mg/L for DBP2-02.

Haloacetic acids (HAA5) are a group of volatile organic compounds that are formed when chlorine, added to the water during the treatment process for disinfection, reacts with naturally occurring organic matter in the water. Some people who drink water containing HAA5 in excess of the MCL over many years may have an increased risk of getting cancer.

You do not need to use an alternative water supply. However, if you have health concerns, you may want to talk to your doctor to get more information about how this may affect you.

We are taking the following actions to address this issue:

- 1. We have increased flushing activities in the affected areas. Moving water through mains is one means of decreasing the formation of disinfection byproducts in distribution.
- 2. We are investigating a source water change. This water is purchased surface water from Houston County WCID 1. While moving water through our lines can decrease disinfection by-product formation in our system, our efforts are limited by the quality of water supplied at our purchase point. For this reason, and since disinfection by-product problems are limited to our surface water systems, we are investigating a transition to ground water for your area. Ground water has fewer organic precursors and is less prone to formation of disinfection by-products.

# Monitoring Requirements Not Met for Consolidated WSC Latexo City Plant Y A

Our system failed to collect every required coliform sample. Although this incident was not an emergency, as our customers, you have a right to know what happened and what we did and are doing to correct these situations.

We are required to monitor your drinking water for specific contaminants on a regular basis. Results of regular monitoring are an indicator of whether or not our drinking water meets health standards. During 03/01/2019 - 03/31/2019 we or did not complete all monitoring or testing for coliform bacteria and therefore cannot be sure of the quality of your drinking water during that time.

#### What should I do?

There is nothing you need to do at this time. You may continue to drink the water. If a situation arises where the water is no longer safe to drink, we are required to notify you within 24 hours.

## What is being done?

Routine samples pulled before this monitoring period and after this monitoring period were all absent of coliform bacteria. Additionally, special bacteriological samples pulled in this area during March 2019 maintenance activities were also absent of coliform bacteria.

This monitoring was formerly completed by a single employee. Cross-training is underway to ensure that *all* licensed operators know how and when to complete this routine monitoring.

# Mandatory Language for a Monitoring and Reporting Violation Operational Evaluation Report

The Consolidated WSC Latexo City Y A water system PWS ID TX1130012 has violated the monitoring and reporting requirements set by the Texas Commission on Environmental Quality (TCEQ) in Chapter 30, Section 290, Subchapter F. Public water systems in exceedance of an operational evaluation level are required to conduct an evaluation of their source water, treatment and distribution operations and submit a report of their findings to the TCEQ.

We failed to conduct an operational evaluation or submit a report to TCEQ. This violation occurred in the monitoring period quarter 1, 2019.

We are taking the following action to address this issue:

This was an internal administrative error. To prevent the chance of recurrence, we are taking steps to simplify our compliance documentation, through consolidation of public water system IDs with identical or similar source waters.
